- The Scholarship Application must be received by **Monday, August 29, 2011**. Applications received after this date will not be accepted.
- You must be a paid member of the CLEARs Inland Chapter in good standing.
- You must have a minimum of one year Record Supervisor experience or equivalent, i.e. Records Lead or Shift Supervisor.
- You must provide written verification that your agency will not provide funding for the seminar.

In addition, the Scholarship Committee will also consider the following factors:

- Are you an active participant in the Inland Chapter? For example, are you a Board member, serve on a committee or hosted a monthly meeting?
- The number of meetings you have attended in the last 12 months.
